A Special Session of the Clay Community Schools Board of Trustees was held in the Board Room of the Central Administration Office, 1013 S. II. Teacher Collective Bargaining Ratification Meeting – Teacher Contract Proposed changes to the CCCTA Master Contract were included in the board packet. Superintendent Rayle presented a review of the proposed changes, which were the same ones reviewed at the special session on September 24, 2024.

Mr. Reberger then stated that at this time, according to state statute, public comments regarding the teacher contract would be permitted. Hearing no public comments, a motion to approve the CCCTA contract was made by Dr. Shaw. Mr. Jackson seconded, and the motion was approved by a 5-0 vote.
