Proposed changes to the bus driver handbook were included in the board packet. No vote was required. The handbook is to be brought back to the August 8 regular session for a second reading and approval.

V. Secondary Student Handbook Update Regarding Chromebooks – First Reading

Information regarding Chromebook-specific discipline that is to be administered for Internet violations and misuse and abuse of the Chromebooks by secondary students was included in the board packet. This was a first reading, so no vote was required.

Although not on the agenda, Superintendent Fritz offered a heartfelt prayer and a compassionate statement regarding the Rylee Rogers family: He noted that any time the school corporation loses a member of the school family, it is quite a loss, especially when it is one of our young people. Prayers were with her immediate family and her Northview family, and he prayed that God would bless them in this time.
