#### MINUTES OF MEETING OF BOARD OF TRUSTEES OF CLAY COMMUNITY SCHOOLS

A regular session meeting of the Clay Community Schools Board of Trustees was held at the Central Administrative Office, 1013 S. Forest Avenue, Brazil, IN 47834, on Thursday, December 12, 2019. Kevin Kumpf, Michael Shaw, Andrea Baysinger, Tom Reberger, Amy Burke Adams, and Charley Jackson were present. Lynn Romas was absent.

Prior to the Call to Order, bids were opened for fiber WAN as well as LAN Hardware and wireless networking equipment. Four bids were received for fiber WAN, and eight bids were received for LAN Hardware; a summary of the bids will become a part of the official minutes. After review, a recommendation for approval of the bids selected for acceptance will be presented during the January 9, 2020, board meeting.
