All bids must be submitted in a sealed envelope with a statement on the outside of the envelope reading "<u>Sealed Bid: One to One Hardware for Clay Community Schools.</u>" All bids received after the designated time will be returned unopened. The bids must be submitted on or before 2:00 p.m. on May 26, 2020 to Mark Shayotovich, Clay Community Schools, 1013 South Forest Ave Brazil, Indiana 47834. The Board of School Trustees will award contracts for the products on May 28, 2020.

Each bidder shall furnish the following with his bid:

- 1. Non-Collusion affidavit must be executed.
- 2. Place bid prices on the appropriate specification form.
- 3. A cover letter with a brief statement on the history of the firm
- 4. Reference of at least two (2) other school corporations in Indiana using equipment provided by the bidder.

Any bidder may withdraw his bid at any time prior to the scheduled time for receipt and opening of bids. No bids shall be withdrawn after the opening of bids without the consent of the owner.

Acceptance of any bid will be based on the assumption that the bidder fully understands the specifications and conditions, and accepts them without reservation.

Should any person submitting a bid have a question as to the true meaning of specifications; he may request interpretation from the owner. Failure to request clarification shall be the sole responsibility of the bidder.

The Board of School Trustees reserves the right to reject any and all bids and waive any informalities. Any such decision shall be considered final and not subject to further recourse. The Board of School Trustees may accept bids for the various categories of computer hardware and software from different vendors. If a vendor wishes to bid only certain categories, they are not restricted from bidding.

#### **DELIVERY:**

All equipment shall be delivered in accordance with owner's directions at the time the purchase order is issued. Payment will be made after successful delivery and testing of <u>all</u> equipment.

Successful bidder shall include as part of the bid the cost of freight and transportation of said items of equipment. Freight prices shall include all costs of unloading the trucks and the placement of all boxes, crates, packages and parcels within the building.

The seller shall assume all responsibility on all items damaged in shipment. The owner shall not assume any obligations concerning damaged equipment.

### **EQUIPMENT SAFETY STANDARDS:**

All items bid, where applicable must meet Federal (IOSHA) and State safety standards and specifications.

#### WARRANTY/MAINTENANCE

Successful bidder shall provide a minimum warranty for all equipment as stated on the bid specifications form and shall be responsible to repair or replace all broken or unusable pieces of equipment.

The successful bidder shall have a self-maintainer program that Clay Community Schools may participate in. This program shall allow Clay Community Schools' technology personnel (with the proper certification) to order parts or pieces of equipment and replace or repair such parts and equipment. All details of the bidders self-maintainer program shall be included as part of their bid.

#### **QUALITY:**

# All Equipment being bid shall be new and all computers must contain identical components

Specifications have been organized in such a manner that bidders may be able to determine quality. A manufacturer's number and /or name may be used to indicate quality standard; this information is not an attempt to limit bidders in any way. Bidders may submit bids for items of proven superior quality or of equal quality specified, provided that the bid is clearly marked "alternate bid" and a full description of the item shall accompany the bid.

### **SELECTION FACTORS:**

All items bid will be reviewed and compared for quality, conformity to specifications, and price. Factors that will be given consideration by the owner in making this award are listed below:

- 1. Compliance with bid specifications.

- 3. Sufficiency and expandability of the proposed hardware.
