MINUTES OF MEETING OF BOARD OF SCHOOL TRUSTEES OF CLAY COMMUNITY SCHOOLS

A Special Session of the Clay Community Schools Board of Trustees was held at the Central Administrative Office, 1013 S. Forest Avenue, Brazil, IN 47834, on Tuesday, August 28, 2012. Tammy Beasley, Jennifer Kaelber, Tina Heffner, Forrest Buell, Rob Miller, Ron Scherb and Amy Burke Adams were present.

I. Call to Order

The special session meeting was called to order at 7:05 p.m. by board president Rob Miller.

II. Budget Hearing on 2013 Budget, Capital Projects Plan, School Bus Replacement Plan and Levy Neutrality

Director of Business Affairs Tim Gorman presented information to the board regarding the proposed 2013 budget, Capital Projects Plan, School Bus Replacement Plan and Levy Neutrality. Mr. Gorman and Superintendent Tucker noted the following:

- The overall assessed value was up about 1½%.
- In past years the approved tax rates had been reduced by about one-third from the advertised rates, so the advertised amounts are not what the school corporation will get.
- When preparing the budget, the assessed valuation must be reasonably low enough, so an assumed reduction in assessed valuation of approximately 15% was used, which automatically inflated tax rates. However, the tax rates that were advertised are not what the corporation expects to receive.
- When comparing this year's proposed budget to last year's approved budget, there is an increase, primarily due to a half percent increase in teacher salaries, which translates into an \$86,000 increase.
- General Fund revenue from the state is based on the ADM count in September.
- The General Fund and the Rainy Day Fund are not counted as property-tax based funds.
- The Capital Projects Plan is down about \$46,000 compared to last year.
- An allocation was included in the Capital Projects Plan in case repair or replacement is needed for the water tower at Van Buren Elementary.
- The proposed Transportation Fund budget is down \$88,000, about 3% less than last year's budget.
- The School Bus Replacement Plan is up because the corporation is scheduled to replace seven buses.
